

PRIVACY POLICY

Internet Intranet Resourcing Consultancy Limited (Company Registration number 3156292) (also know as IIRC Ltd) ("We"), 7 Medway Close, Skelton-in-Cleveland, TS12 2JZ, England.

This policy (together with our website terms of use and any other documents referred to in it) sets out the basis on which we will process personal data we collect from you, or that you provide to us, as a result of you using our website or any services we provide to you. **Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.**

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

Information that you provide to us.

Information provided by others about you.

IP ADDRESSES AND COOKIES

We collect information about your computer, including where available your IP address, operating system and browser type, to improve services to you. This is statistical data and does not identify any individual and we will not collect personal information in this way.

We do not use cookies to track your general internet usage patterns.

TRANSFER OF PERSONAL DATA ABROAD

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of your order and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.
